I understand that as a partner I have a responsibility to:

1. Understand, support and promote the Vision and Mission of the Hamilton Civic League and communicate that to the business or organization I represent.
2. Conduct all business and/or volunteer activities in a reputable manner, to reflect honourably upon the Hamilton Civic League.
3. Maintain the non-partisan nature of the Hamilton Civic League in the interactions between it and the business or organization I represent.

I understand that some partner organizations may choose to voluntarily commit to additional support of the Hamilton Civic League, such as meeting space, donations of time, money, or gifts in kind. I understand any additional commitment of this sort is completely voluntary and in addition to the basic partnership requirements, and that all donations will further the non-partisan work of the Hamilton Civic League.

I understand that failure to adhere to the obligations outlined above can result in the termination of this partnership by the Hamilton Civic League's Board of Directors. I also agree that I have no legal recourse if my partnership is revoked. All partnership donations are non-refundable. I agree to release, defend, indemnify and hold harmless the Hamilton Civic League, its Board of Directors, volunteers and other partner organizations against any and all claims, charges, demands, damages, liabilities, losses, expenses, and liabilities of whatever nature, including negligence, and howsoever arising, that may arise from, or are in any way connected to, my or the organization I represent's partnership, membership, participation, involvement, or association with the Hamilton Civic League.
